 As per Section 22 of the Real Estate (Regulation & Development) Act, 2016, the qualifications for the post of Member in the Real Estate Regulatory Authority are as follows:-

2.1 A Member of the Authority shall be appointed from amongst persons having adequate knowledge of and professional experience of at least fifteen years in the case of Member in urban development, housing, real estate development, infrastructure, economics, technical experts from relevant fields, planning, law, commerce, accountancy, industry, management, social service, public affairs or administration.

2.2 Provided further that a person who is, or has been, in the service of the State Government shall not be appointed as a member unless such person has held the post of Secretary to the State Government or any equivalent post in the State Government or Central Government.

3. As per Section 23 of the said Act, the member of the Real Estate Regulatory Authority for NCT of Delhl and UT of Chandlgarh shall hold the office for a term not exceeding five years from the date on which they enter upon their office, or until they attain the age of sixty-five years, whichever is earlier and shall not be eligible for re-appointment. Moreover, before appointing any person as a Member, the appropriate Government shall satisfy itself that the person does not have any such financial or other interest as is likely to affect prejudicially his functions as such Member.

4. Salary and allowances payable and other terms and conditions of service of the Member of the Authority shall be governed as per provisions of Section 24 read with Rule 18 of the Real Estate (Regulation and Development) Act, 2016.

5. Interested persons may apply as per the enclosed proforma of application and application should be in typed/printed form. The persons who are in Government service at present/those who have retired during last six months may send their applications only through proper channel alongwith latest Vigilance Clearance Report otherwise application shall not be entertained and rejected accordingly. Incomplete applications will not be accepted and each applicant should have duly filled up the self declaration as a part of the proforma of application which is mandatory.

6. Persons who wish to apply must have essential qualification as per section 22 of the said act before applying for the above said post. Otherwise, application shall be rejected without any intimation. Further, persons are requested to enclose essential documents which indicate the total work experience of the person.

7.
