This Court invites sealed tender(s) from Cisco Authorized vendor(s) with validity of rates for 180 days from the date of closing of instant tender for award of Onsite Comprehensive Annual Maintenance Contract (AMC) with back-to-back support from CISCO for a period of two (02) years (initially for one year which shall be renewed at the same rates after completion of first year at the sole discretion of Delhi High Court on the basis of the performance of the vendor) in respect of CISCO Switches, 10G LRM Modules, LIUs and fiber/patch cords installed in the premises of this Court along with the services of one CCNA certified Resident Engineer for AMC period in High Court of Delhi as per the following details:-

*Note: The participating firm(s) / vendor(s) must submit duly filled in price bid sheet as per Annexure-'A' and also have to furnish a duly filled in/signed/stamped undertaking in original (strictly as per Annexure-'B')

The terms & conditions of this tender are as under:-

1. Authorized Cisco firm(s) / vendor(s) authorized by the OEM intending to participate in the instant tender are requested to submit the necessary quotation(s) along with the copy of current authorization letter of the OEM and Earnest Money Deposit (EMD) of 3% of total proposed cost (incl. GST) by way of Demand Draft/Bankers Cheque/Pay Order drawn in the favour of "The Registrar General, Delhi High Court" payable at New Delhi.

- 2. Quotations received without EMD **shall be summarily rejected** and no request for waiver of EMD will be entertained.
- 3. Rates offered in the Tender shall not be enhanced during the period of contract.
- 4. The tenderer (s) must be an authorized vendor of CISCO with a minimum experience of <u>03</u> years for providing service support in Government/Public Sector Undertakings dealing in this field. Relevant documentary evidence (duly signed & stamped by the authorized person) and confirmation regarding above must be enclosed, duly flagged and numbered failing which the tenderer (s) shall stand disqualified.
- 5. Successful firm / vendor will be required to depute one experienced CCNA Certified Engineer for attending the complaints independently.
- 6. Sealed envelopes containing Price Bid & EMD must reach to the AOJ (IT Branch), Lawyers' Chamber Block-III, Room No. 6, Ground Floor, Delhi High Court on or before **20.12.2023** till **05:30 P.M.**
- 7. The sealed envelopes should be addressed in the name of "The Registrar General, Delhi High Court, New Delhi" and the <u>subject</u> & <u>due date</u> for which the quotation is submitted should be clearly superscribed on the envelope.
- 8. The validity of rates must not be less than 180 days from the last date of submission of quotations. Quotations with less period of validity of rates shall be summarily rejected.
- 9. No quotation shall be entertained <u>after due date</u>. Sealed Envelope(s) <u>without subject</u> as referred to above having been mentioned on them shall be **summarily rejected**.
- 10. The offer of quotation must be tendered strictly in the format prescribed at <u>Annexure-'A'</u> of this tender. Quotation(s) offered in any other format than prescribed shall be liable to be rejected.
- 11. The Demand Draft/Bankers Cheque/Pay Order towards EMD of all the tenderers, except the lowest three, shall be returned to vendors on their written request after finalization of Tender Process & EMD of successful tenderer will be returned only after fulfilling all codal formalities.
- 12. The Demand Draft/Bankers Cheque/Pay Order of L-2 & L-3 firm(s)/Vendor(s) will be returned upon written request after issuance of the Award Letter to the successful tenderer. If the offer of quotation is withdrawn by the tenderer before/after opening of tender or if any other default is found in the quotation, the amount of EMD shall be forfeited and the firm will be blacklisted from participation in future tenders of this Court.
- 13. If multiple quotations are submitted by a firm / vendor, all such quotations submitted shall be liable to be rejected at the first instance.
- 14. After opening of the sealed quotation by the independent officer of this Court if any correction is found in the offered rate which renders the whole Tender process doubtful or ambiguous, the said offer of quotation shall be summarily rejected.
- 15. The selected vendor will have to execute Service Agreement with Delhi High Court for the satisfactory performance and will also have to furnish the performance Bank Guarantee @ 8 % of the AMC amount for the AMC period plus two months.
- 16. The firm/vendor shall also have to furnish a duly filled in/signed/stamped undertaking in original (strictly as per Annexure-'B') that neither the firm nor its Partner/Director/Proprietor has been blacklisted/banned and its Business dealings with

the Central/State Government/Public Sector Undertakings/Autonomous Bodies has/have been banned/terminated on account of poor performance/conduct and also that all the terms and conditions of the instant Tender Notice are acceptable to them. The quotation received without undertaking shall be summarily rejected.
