No claim of interest shall be entertained on EMDs.
- 2. The quantity of the items may increase/decrease.
- 3. Quotations received without EMD shall be summarily rejected and no request for waiver will be entertained.
- 4. The tenderers are expected to examine all the instructions, proformas, terms & conditions and specifications in the tender documents. Failure to furnish all information sought for in the tender document in any respect will be at the tenderers' risk and may result in rejection of the tender.
- 5. Sealed envelope containing quotation (strictly as per Annexure—'A') & EMD must reach the Admn. Officer (Judl.) (P&P-II), Ist Basement, Administrative Block, Delhi High Court, New Delhi on or before 16.04.2024 till 5:30 P.M. No quotations shall be entertained after 16.04.2024.
- 6. The quotations must clearly mention the rates inclusive of GST/Tax rate, technical specifications, guarantee/warranty period and the delivery schedule of the product being offered.
- 7. The envelopes superscribing on the top "Quotation for Furniture & Furnishing Items" should be addressed to "The Registrar General, Delhi High Court, New Delhi". Envelope(s) received without subject superscribed shall be summarily rejected.
- 8. The rates offered by the tenderer(s) should be valid for 90 days from the last date of submission of quotations. Quotations without the validity of rates shall be summarily rejected. Rates quoted shall include delivery charges at 21 Canning Lane in Delhi.
- 9. The time is the essence of the tender. The supply of the item as per the required specifications shall be required to be delivered strictly as per the schedule given by the successful tenderer and agreed upon by this Court.
- 10. The tenderers shall also be required to place the furnitures at the site i.e. Bungalow No. 21 Canning Lane, New Delhi as per requirement of this Court.
- 11. This Court is not bound to accept the lowest tender and reserves the right to reject or accept any or all of the tenderers, partly or completely, at any time without assigning any reason thereof.
- 12. The EMD of all the tenderers, except those of the lowest three tenderers, shall be returned to tenderers on their written request after finalization of Tender Process. The EMD of successful tenderer will be returned only after supply and successful execution of the purchase order placed on the said tenderers after fulfilling all codal formalities against receipt.
- 13. The EMD of L-2 & L-3 will be returned after issuance and complete execution of the Purchase Order to the successful tenderer(L-1). If the offer of quotation is withdrawn by the said tenderer(L-1) after opening of tender or on account of any other default, the EMD shall be forfeited and the said vendor will be blacklisted to participate in future tenders of this Court.
- 14. The payment will be made after full supply is received and accepted as per approved specifications against single supply order. No advance payment will be made in any case.
- 15. Overwriting/over-typing or erasing of the figures which render it doubtful or ambiguous are not allowed and shall render the tender invalid.

- 16. The tenderers shall be required to furnish an undertaking (strictly as per Annexure—'B') that the firm/Partner/Director/Proprietor has not been blacklisted/banned and its Business dealings with the Central/State Government/Public Sector Undertaking/Autonomous Bodies have not been banned/terminated on account of poor performance/conduct and also that all the terms and conditions of the instant Tender Notice are acceptable to them. The quotation received without undertaking shall be summarily rejected.

- 19. All the pages of quotation including the documents submitted therein must be duly signed and stamped failing which the offer shall be liable for rejection.
- 20. In case of non-supply or short supply of items by the tenderer, if this Court is required to make purchase from outside at higher rates, the loss, if any, sustained by this Court would be recovered from the tenderer.
- 21. The tenderers shall furnish designs of the aforesaid items along with their bids and shall be ready with a 3D presentation of the furniture layout which they will be required to present as and when called.
- 22. Tenderer may visit the site i.e. Bungalow No. 21, Canning Lane, New Delhi-110001 before submitting their tenders.
