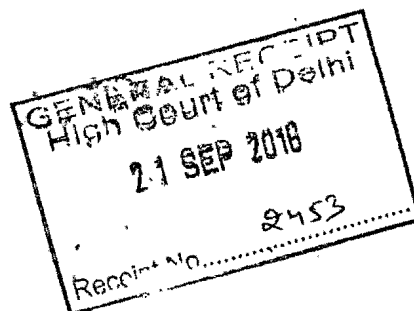



## CIRCULAR

In pursuance to modifications in Permanent Lok Adalat (Other Terms and Conditions of Appointment of Chairpersons and other Persons) Rules, 2003 as amended vide notification F. No. A-60011/10/2012-Admn. III (LA)/LAP (JUS) dated 22<sup>nd</sup> June, 2016 of Ministry of Law and Justice, the Hon'ble Executive Chairperson, DSLSA has been pleased to amend/modify the Terms and Conditions relating to selection/appointment on the post of Chairperson and Other Persons for Permanent Lok Adalats (PUS) to be established under Section 22. Accordingly, the relevant conditions as mentioned in the advertisement dated 06.10.2015 & 23.02.2016 are hereby modified as mentioned in column B :

Sl. No.	Column A	Column B
1	The initial appointment of Chairpersons and Other Persons shall be for 2 years only, which shall be extendable at the discretion of Hon'ble Executive Chairpersons of DSLSA for a further maximum period of 3 years. Thus the total period of office shall not exceed 5 years or the attainment of the age of 65 years for DHJS and 67 years for retired High Court Judges whichever is earlier and they shall not be eligible for re-appointment.	The Chairpersons and Other Persons shall hold office for a term of the five years or till the age of sixty five years. However, the initial appointment for Chairpersons and Other Persons may be for 2 years only which may be extendable at the discretion of the Hon'ble Executive Chairman of the DSLSA for a further maximum period of the 3 years.
2	The sitting fee of Other Persons/Members shall be Rs. 1250/- per sitting.	Other Persons shall be entitled to a sitting fee of Rupees One Thousand Five Hundred per sitting.
3	The Chairpersons or Other Persons/Members shall be provided pool car/Staff Car, if the Chairpersons or Other Persons/ Members is not availing the pool car/staff car, they shall be entitled to the cost of upto 70 liters of petrol diesel or 50 Kgs of CNG/LPG per month on production of certificate of actual utilization and cash receipt from the fuel station.	For the purpose of attending the sitting of Permanent Lok Adalat, the Chairpersons and Other Person shall be entitled to conveyance allowance of rupees five thousand per month.

Rest of the terms and conditions of service of Chairperson and Other Persons of the Permanent Lok Adalats (PUS) including the resignation and removal of such persons shall be governed by the terms and conditions outlined in Notification F. No. A-60011(3)/2001-Admn.III (LA) dated 2<sup>nd</sup> January, 2003 of the Ministry of Law and Justice, Govt. of India and other relevant rules applicable to the Govt. Servants in-force.
