Post: LAW RESEARCHER

Essential Qualification. Any fresh Law graduate or a lawyer with few years practice at the Bar. Should have been enrolled/registered with any Bar Council.

<u>Mode of Selection</u>. Selection shall be made on the basis of interview by the Hon'ble Judge(s) of this Court.

<u>Compensation/Remuneration</u>. A monthly consolidated remuneration of Rs. 25,000/will be paid to Law Researchers.

General Information. The above engagement is a full time job and is purely contractual in nature. It would not confer any right of permanent employment in Delhi High Court. It is made clear that Law Researchers duly engaged will not be entitled to practice or take up any other assignment during the period he/she work as Law Researcher in this Court.

Law Researchers will not appear before the Hon'ble Judge(s) to whom they will be attached, for a period of one year after the conclusion of their tenure as Law Researcher. Their term can be terminated before the expiry of their period of engagement, without notice. They will also not be allowed to appear in a case handled by the Hon'ble Judge(s) during their tenure with the Hon'ble Judge(s) regardless of whether they have worked on that case or not.
