3. Age Limit.

(a) <u>**Deputation**</u>. The maximum age limit for appointment on deputation shall not be exceeding 56 years as on the closing date of receipt of applications.

(b) <u>**Re-employment on contract basis**</u>. The maximum age limit for reemployment on contract basis is 64 years.

4. Please note that:-

(a) Applications received after the Jast date will not be entertained.

(b) Applications for deputation will have to be routed through their parent departments.

(c) Applications for one year on re-employment on contract basis only from retired Central/State Govt. /Court Staff/Tribunals/Statutory bodies and Autonomous Bodies will be considered.

(d) Candidate can only apply for one post. If applied for more than one post applications shall automatically be treated as cancelled for all the posts.

5. Number of vacancies may vary and filling up of the post(s) is at the discretion of the Competent Authority.

6. (a) The departmental officers in the feeder grade who are in direct line of promotion, shall not be eligible for consideration for appointment on deputation. Similarly, a deputationist in the Armed Forces Tribunal shall not be eligible for consideration for appointment by promotion channel.

(b) The period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other Organization or Department of the Central Government shall not ordinarily exceed three years. The maximum age limit for appointment by deputation shall not exceed 56 years as on the closing date of receipt of application.

7.
