Applications are invited from Indian Nationals born on or after 01.01.1990 <u>for appointment</u> of 04 Law Researchers at Delhi Judicial Academy on a consolidated honorarium of Rs. 25,000/± per month (likely to be revised), initially for a period of one year on contract basis extendable by another one year, at the sole discretion of the Appointing Authority.

Short listed candidates will be called for an Interview on a date to be intimated later.

The candidate must be a Law Graduate from a recognized university. Those who have appeared for the final examination, may also apply. Such candidates, however, will have to produce the proof of having passed the final law examination by the date fixed for holding the interview.

The applications shall be submitted in the prescribed form (Annexure "1").

The application shall bear the recent passport size photograph of the applicant and accompanied by self attested copies of relevant documents in support of the information supplied against column no. 9, 10, 11 and 12. The application shall be submitted in a closed envelop, clearly mentioning on the envelop <u>"Application for appointment as Law Researcher at Delhi Judicial Academy"</u>, addressed to the Director (Administration), Delhi Judicial Academy, Sector-14, Dwarka, New Delhi-110078. The application should reach the Academy on or before <u>21.09.2017</u> by 4:00 p.m.

The applications which are incomplete, unsigned and received after prescribed date and time, shall be rejected summarily and no enquiry will be entertained in this regard.

It is made clear that the above engagement is a full time job, purely contractual in nature. It would not confer any right of permanent employment at Delhi Judicial Academy. It is also made clear that a Law Researcher will not be entitled to practice or take up any other assignment during the period of he/she works as Law Researcher at the Academy.
