## VACANCY CIRCULAR

Applications are invited for filling up the post of Chairperson, Delhi Judicial Academy, New Delhi. As per the Administrative Directions for the purpose of recruitment, the method of recruitment for the post of Chairperson, Delhi Judicial Academy is as under:

"By direct recruitment or on deputation on recommendation of the Search Committee constituted by the Patron-in-Chief for this purpose."

The eligibility criteria, terms of appointment, salary, allowances and other perquisites for the post of Chairperson, Delhi Judicial Academy are as under:-

- "(a) A person shall not be qualified for appointment as Chairman unless, he or she is, or has been, a Judge of a High Court, or is a distinguished Academician having teaching experience of not less than twenty five years as a lecturer, and experience as a Professor of Law of not less than seven years.
- (b) The term of the Chairman shall be initially for two years which may be extended for another two years. The upper age limit for appointment of Chairman shall be seventy years. However, in suitable cases, having regard to the eminence and experience of the person and subject to physical fitness and mental agility, the age limit of seventy years can be relaxed by Hon'ble the Chief Justice in consultation with the Judicial Education and Training Programme Committee of the High Court.
- (c) The Chairman shall be paid salary, allowances and other perquisites as are admissible to the Vice Chancellor of a Central University from time to time.
- (d) Provided that in case, Chairman would be a person who had been a Judge of the High Court, he shall be paid salary, allowances and other perquisites including sumptuary allowance as are admissible to a sitting Judge of the High Court."

Applications along with the bio-data as per the attached proforma, duly filled in, a passport size photograph and self-attested copies of the relevant certificates/testimonials addressed to the Registrar General, Delhi High Court, Sher Shah Road, New Delhi-110503 may be submitted in the Establishment Branch, Delhi High Court, New Delhi or sent by registered AD post, so as to reach on or before 15-09-2018.

Applications which are incomplete, unsigned and received after the due date shall be rejected summarily. Only eligible and short listed candidates will be called for an interview, if any, on a date to be intimated later and no TA/DA shall be paid to the candidates for the purpose.
