# 3. Age Limit.

- (a) <u>Deputation</u>. The maximum age limit for appointment by deputation shall not exceed 56 years as on the closing date of receipt of application.
- (b) Re-employment on contract basis. The maximum age limit for re-employment on contract basis is 64 years.

#### 4. Please note that:-

(a) Applications for deputation will have to be routed through their parent departments.

(b) Applications for one year on re-employment on contract basis will only be considered from retired Central/State Govt. /Court Staff/Tribupals/Statutory bodies and Autonomous Bodies.

- 5. The departmental officers in the feeder grade who are in direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, a deputationist in the Armed Forces Tribunal shall not be eligible for consideration for appointment by promotion channel.
- 6. The period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other Organization or Department of the Central Government shall not ordinarily exceed three years.
- 7. The application(s) in the prescribed Performa (Annexure I) from eligible officers/officials who can be spared on deputation in the event of their selection may be forwarded by the Departments to the Principal Registrar, Armed Forces Tribunal, Principal Bench, Block-VIII, Sector-1, RK Puram, New Delhi 110066 along with photo-copies of the Annual Confidential Reports for the last five years and vigilance clearance certificate.
