FAREWELL SPEECH ON 13.04.2017

At the outset I express my deep sense of gratitude for the kind words said about me.

What you have said truly reflects the measure of love, affection and kindness of the Bar and Bench towards me. I am overwhelmed and I will cherish the same forever.

Having practiced as an advocate for about two decades and then having been on the Bench for about 16 years, it is a long and strong attachment I have developed with the system of administration of justice.

When I started the journey way back in the year 1981 as a young advocate with no legal background, it was completely unplanned.

But God is so kind to me that the exalted office of the Chief Justice of Delhi High Court became the destination to this splendid journey.

It is my great fortune that I could come as Chief Justice to this Court - the most prestigious High Court of the country which has carved out a special position for itself amongst the premier courts not only within India but also internationally.

It is really a matter of great pride for me to achieve the distinction of being the first woman Chief Justice of this prestigious Court.

I am the first in my family to enter the legal profession and when I joined the Bar, except possessing a law degree I knew nothing about the legal profession. In fact, I joined the profession by chance and it was never my choice.

During the early days in my career, on many occasions I had a serious doubt whether I could continue.

I am grateful to my senior Sh.Koka Raghava Rao who supported and encouraged me to continue in the profession. I never even dreamt of, but he strongly believed that one day I would make a distinct mark in the field of law.

I am extremely happy that my revered senior and mentor Shri Raghava Rao is present in this august gathering and is proud to see the rise of his disciple in the career. I shall forever be indebted to him for his true blessings and guidance which enabled me to reach this stage.

I am also very fortunate to have the support of my parents and my siblings who have always encouraged me to continue in the legal profession and extended the fullest support at every stage of my life.

I always believed that the office of a Judge is not a mere matter of status and authority but it is a responsibility to be discharged with great care and compassion.

This has always been in my mind while performing my duty as a Judge and perhaps this is one of the reasons why I have concentrated all through my tenure on quality of justice rendered rather than the quantity.

I also strongly believe that the members of the Bar representing the litigant parties are better informed both with regard to the facts of the case as well as the legal issues.

Therefore, I always made it a point to give a patient hearing to the counsel appearing for the parties and to understand the case before passing any order. It is my great fortune that during my tenure as Chief Justice we have celebrated the momentous occasion of this Court setting a milestone of half a century in its journey.

I am proud to state that Delhi High Court today occupies a unique place in the judicial system of our country on account of the high quality of litigation being dealt with in different fields of law. I consider myself privileged and fortunate to be in this Court for some time to serve the cause of justice in a humble way.

I have seen and observed that the Bar in Delhi High Court has been very co-operative and maintained cordial relationship with the Bench to upkeep the high esteem of this institution. It is really appreciable that the Bar fully understands its responsibility towards the Court and provides the desired assistance.

I am very happy and grateful to the learned members of the Bar for being very kind and affectionate towards me and for having extended the fullest co-operation to enable me to discharge my duties on the judicial side. I can say without hesitation that no unpleasant incident has taken place in my Court at any point of time.

During my tenure as Chief Justice of this Court, I had the good fortune of sharing the Bench with Justice Pradeep Nandrajog, Justice R.S. Endlaw, Justice Jayant Nath, Justice V.K. Rao and Justice Sangita Dhingra Sehgal. I am grateful for the great assistance received from each one of them.

The support extended and the affection shown towards me by all my brother and sister Judges has been quite phenomenal and I take this opportunity to thank each one of my brother and sister Judges for the love and affection showered on me.

Whatever progress I could achieve for development of this Court on the Administrative Side could become possible only with the constant support and insightful suggestions by my colleague Judges.

I am very grateful to the members of the Registry of the High Court and all the staff members who always extended their services whole-heartedly.

A special mention has to be made about the valuable assistance rendered by Justice Vinod Goel and Justice Chandra Shekar while they were functioning as the Registrar General and Registrar Vigilance respectively during the first two years of my tenure. I take this opportunity to thank them for all the support extended.

I also thank Mr.Girish Kathpalia, the Registrar General, Mr.Dinesh Kumar Sharma, Registrar (Vigilance) and Mr. H.C. I thank the Almighty for giving me such wonderful parents. I wish and pray that all girl children are blessed with such parents who believed in respecting the sentiments of a daughter and supporting her in all situations. I am the most fortunate daughter to receive such support, love and blessings of my parents all through.

I am also very fortunate to be a member of a closely knitted family.

My Brothers - Mr. G.V R Murthy and Dr. Jagannath, my sisters in law- Mrs. Padmini and Mrs Sai Sudha, my nephews Vijay and Ajay and my dearest friends Mrs. Sarada and Mr. Srinivas have made it a point to be here with me today.

It is a matter of great joy for me to have the company of many of my friends, well wishers and former staff members who have come all the way from Hyderabad to be with me and to make me happy and confident while laying down the office.

Words are inadequate to express my gratitude to them for their love and affection.

I must also say about Ms. Anureeta Sharma, who has been the only Law Researcher truly associated with me during my entire tenure. But for her unconditional support in each and every endeavor of mine, her love & affection and constant efforts to make me happy and comfortable always, I would not have been in a position to overcome the stress attached to the high office I held.

Before concluding, I must say that as I part with this exalted office, I am the most contended person today.

I am laying down the office with utmost satisfaction of discharging the pious duty ordained to me by the Almighty to the best of my ability.

Many eminent Judges served and laid down their offices at the end of their tenure and today it is my turn to take leave of you. The time spent by me during the long tenure of 16 years on the Bench, more particularly the last three years I have spent in this Court remains an extra-ordinary part of my life forever.

I must also say that I am greatly indebted to this institution which gave me not only the name and fame but also maturity in thinking and clear notions about the values of life.

I conclude wishing this Court continued progress and prosperity.

I am sure that the members of the Bar will ensure that the prestige, dignity and independence of this Court will ever continue.

Thank you once again for the co-operation extended and the love & affection showered on me.

I shall forever, carry with me and cherish the memory of the most remarkable years I have spent amidst all of you in this Court.
