Sub: Fresh Tender for purchase of one no. of Canon EF 16-35mm f/4L IS USM Lens and one no. of Canon EF 24-105mm f/4L IS II USM Lens.

This Court recalls its previous Tender No. 3992-98/Sty./DHC dated 01.03.2021 and invites fresh quotations for purchase of one no. of Canon EF 16-35mm f/4L IS USM Lens and one no. of Canon EF 24-105mm f/4L IS II USM Lens.

The terms & conditions of this fresh tender are as under:-

- The lenses must be compatible with CANON 6D Mark II DSLR Camera. 1.
- 2. The authorized vendors are requested to submit the necessary quotation(s) alongwith Earnest Money Deposit (EMD) of 5% of total proposed cost for aforesaid two lenses by way of Demand Draft or Bankers Cheque drawn in favour of "The Registrar General, Delhi High Court" payable at New Delhi. Quotation without EMD shall be summarily rejected and no request for waiver will be) entertained.
- 3. Sealed envelope containing quotation & EMD must reach to the AOJ (IT & Stationery Branch), Lawyers' Chamber Block-III, Room No. 6, Ground Floor, Delhi High Court on or before 29-07-22 till 5:30 P.M. clearly mentioning the technical specifications and warranty period of the product being offered. Quotations for products other than specified above will be summarily rejected.
- The validity of rates should not be less than 180 days from the last date of submission of quotation. 4. Quotations with less period of validity of rates shall be summarily rejected.
- The envelope should be addressed in the name of "The Registrar General, Delhi High Court, New 5. Delhi" and the subject "Quotation for two nos. of Canon Lenses" should be superscribed on the envelope. Tenderers are also directed to specify the name of the firm and contact details on the Envelope.
- No quotations shall be entertained after due date. Envelope(s) without subject shall be summarily 6. rejected.
- It may be noted that the final rates should be mentioned as unit price inclusive of GST and taxes 7. applicable should be clearly and separately mentioned. The quotations must be tendered strictly in the format mentioned in Annexure 'A' of this tender notice. Quotations offered in any other format than prescribed shall be liable to be rejected.

- 8. The DD/Pay order towards EMD of all the tenderers, except the lowest three, shall be returned to vendors on their written request after finalization of Tender Process & EMD of successful tenderer will be returned only after supply and successful installation of the order placed to the firm fulfilling all codal formalities against receipt.
- 9. The DD/Pay Order of L-2 & L-3 will be returned upon written request after issuance of the Purchase order to the successful tenderer. If the offer of quotation is withdrawn by the tenderer before/after opening of tender or any other default, the amount of EMD shall be forfeited and the firm will be blacklisted to participate in future tenders of this Court.
- 10. If multiple quotations submitted by a firm/vendor, all such quotations submitted shall liable to be rejected at the first instance.
- 11. After opening of the sealed quotation if any correction is found in the offered rate which renders the whole Tender process doubtful or ambiguous, the said quotation shall be summarily rejected.
- 12. The successful firm shall be awarded the tender at the quoted/approved rates. In case the firm which has been awarded the tender refuses to supply the required goods at the quoted rates during the said period of 180 days, the firm shall be liable to be blacklisted for participating in future tenders of this Court.
- 13. The firms/vendors offering NET rate (rate without tax component) claiming that they are mandatorily not required to be registered under the GST Act shall submit NET rates only in their quotation and need not mention tax rate & amount and are, further required to submit supporting documents in support of exemption from registration under GST Act viz. CA's Certificate for the F.Y.2021-22 to 2022-23, the latest Copy of Notification issued by Govt of India/Govt of NCT of Delhi duly attested under the seal of the firm to this effect with the quotation. The vendor exempted from Registration under GST Act shall also submit Affidavit on Rs.10/- non-judicial stamp paper affixed with Rs.5/- Notarial Stamp duly notarized by Notary Public as per Annexure 'B'.
- 14. The selected eligible L-1 firm shall be bound to supply the required item within <u>Twenty (21) days</u> from the date of issuance of Purchase Order, failing which the purchase order issued shall be deemed to be cancelled without entertaining any communication in this regard unless sufficient cause is shown (supported by documentary proof) for such lapse. The firm shall be liable to be blacklisted for participating in future tenders of this Court, if failed to supply any cogent reason.
- 15. In case the Purchase Order awarded to the eligible L-1 firm is cancelled due to non-supply of goods within the stipulated period, the Purchase Order will be awarded to the next eligible L-2 vendor/firm.
- 16. The firm/vendor shall also have to give an undertaking (as per Annexure- 'C') that the firm or its Partner/Director/Proprietor has not been blacklisted/banned and its Business dealings with the Central/State Government/Public Sector Undertakings/Autonomous Bodies have not been banned/terminated on account of poor performance/conduct and also that all the terms and conditions of the instant Tender Notice are acceptable to them. The quotation received without undertaking shall be summarily rejected.
- 17. This Court reserves the right to accept the rate(s) of one or more vendor(s) for different lens(es) and give Purchase Orders separately for different lenses.

This Court reserves the right to modify/amend the quotation letter/terms & conditions at a later stage.
