



TERMS & CONDITIONS WITH REGARD TO ACCEPTANCE OF TENDERS AND  
DELIVERY OF THE FOUR CARS OF DELHI HIGH COURT, WHICH WILL BE SOLD ON  
"AS IS WHERE IS BASIS" AS PER DETAILS GIVEN BELOW

1. The bid will be confirmed in favour of the person quoting the highest rate in respect of that vehicle and he/she shall be required to produce proof of his/her identity and residence before acceptance of the balance payment.
2. Only those bids shall be considered who have deposited demand draft/pay order towards refundable earned money as referred above, drawn in favour of "The Registrar General, Delhi High Court, New Delhi" with the concerned officer on or before 20.01.2016 upto 11.00 a.m. writing their name, address, telephone/mobile No. Pan Card on the reverse side of the demand draft/pay order on the spot. The bids without earnest money shall be summarily rejected and no communication shall be entertained in this regard.
3. 50% of the bid amount is to be deposited by the highest bidder, whose bid will be provisionally accepted, within 48 hours by way of demand draft/pay order drawn in favour of "The Registrar General, Delhi High Court, New Delhi" after adjusting the Earnest Money already deposited against a particular vehicle. If the amount is not deposited, the earnest money will be forfeited and the tender next below the highest shall be accepted. Similarly if the second tenderer fails to make payment of the balance amount, his/her earnest money shall also stand forfeited and so on.
4. On final acceptance of the bid, the remaining 50% amount is to be deposited by the highest bidder within one week from the date of communication of final acceptance, by way of demand draft/pay order drawn in favour of "The Registrar General, Delhi High Court, New Delhi", failing which 50% amount already deposited shall stand forfeited and vehicle will be offered to the next tenderer as at Instruction No. 3 above. On payment of the full amount, the vehicle will be handed over to such person, which is required to be removed simultaneously.
5. The signed prescribed form of transfer of vehicles will only be delivered to the successful bidders as per the new Registration Numbers which will be obtained in respect of the vehicles mentioned at Sr. No. 1, 2, & 3 (except vehicle mentioned at Sr. No. 4 bearing ordinary Number) as these vehicles bear VIP/Fancy Nos. which will be retained by this Court.
6. The Registry will deal with the bidders directly and no middle men/agents/commission -agents etc. should be asked by the bidders to represent their cause and they will not be entertained by the Registry.
7. Conditional bid will not be entertained. If the bid is withdrawn by the concerned party at any time after it is provisionally accepted, the money already deposited by him/her shall stand forfeited.
8. The Registry, in its discretion, reserves the right to reject or accept any or all the bids, partly or completely, at any time without assigning any reason therefor. The decision of the officer conducting the auction shall be final.

9. It shall be presumed that the bidder has fully inspected the vehicle before the auction. The Registry shall not be responsible and shall not entertain any complaint in respect of any defect in the vehicle.
10. The officer/staff of this Court and their family members shall not be permitted to participate in the auction.
11. The successful bidder shall get the vehicle transferred in his/her name as per rules, at his/her own cost and responsibility, immediately on taking delivery and in any case within the time prescribed for this purpose. Delhi High Court Registry shall not in any manner be concerned with or responsible for registration of the vehicle and will have no liability whatsoever after the delivery of the vehicle to the successful tenderer.
