- 7. The final rates should be mentioned as per unit price **inclusive of GST** and the taxes applicable should be clearly and separately mentioned.
- 8. The firm/vendor shall quote unit rate both in figures and words.
- 9. The firm/vendor shall also have to give an undertaking (as per Annexure- 'A') that the firm/Partner/Director/Proprietor has not been blacklisted and its Business dealings with the Central/State Government/Public Sector Units/Autonomous Bodies have not been banned/terminated on the account of poor performance/conduct. The quotation received without undertaking shall be summarily rejected.
- 10. After opening of the sealed quotation if any correction is found in the offered rate which render the whole Tender process doubtful or ambiguous, the said quotation shall be summarily rejected.

- 12. The firm/vendor offering NET rate claiming that they are mandatorily not required to be registered under GST Act shall in support, along with the quotation, submit supporting documents viz. CA's Certificate, Copy of Notification issued by Govt. of India/Govt. of NCT of Delhi duly attested under the seal of the firm to this effect.
