- 4. Sealed envelope containing quotation & EMD must reach to the AOJ (IT & Stationery Branch), Lawyers' Chamber Block-III, Room No. 6, Ground Floor, Delhi High Court on or before <u>14/10/2020</u> till 5:00 P.M. clearly mentioning the Version/Model Number/features/configuration of the products being offered.
- 5. The validity of rates should not be less than 180 days from the last date of submission of quotation and tax rate applicable should be clearly mentioned.
