Sub: NOTICE INVITING EXPRESSION OF INTEREST (EOI) FOR ACTIVE DIRECTORY (AD) SERVICES AND PATCH MANAGEMENT FOR WINDOWS DESKTOPS AND SERVERS.

This Court invites Expression of Interest (EOI) from the reputed and experienced firms in the field for Active Directory (AD) services and patch management for windows desktops & servers, having following minimum technical requirements:-

Feature & Important technical requirements:

Hon'ble High Court of Delhi requires implementation of Active Directory Domain Services and Patch Management in its network currently working on Static IP and 7 numbers of VLANs.

1. The proposed solution will be implemented for all computers of Delhi High Court. User desktops may range from 1600 to 2500 machines.
2. Currently users are using Windows 8.1, Windows 10 OS and Servers running on Windows 2008 to Windows 2016 server editions.
3. Services/Roles required are Active Directory Services (Domain Services) and Windows Patch Management System (SCCM/WSUS)
4. Single forest single domain architecture is required for a single site.
5. Minimum two (02) Servers are required on premises alongwith Active Directory Services and Patch Management.
6. User Profile and Data Migration will be required from Workgroup to Domain.
7. The solution proposed should include any additional details/features required to bring out the latest features, functions and industry standards.
8. Required Solution must cause no impedance in the client's performance.
9. Five (05) years of onsite support is required alongwith availability of sufficient number of onsite engineers from 8 A.M. To 8 P.M. Real time monitoring is also required, after checking the existing network of this Court.

A compliance statement against the above-noted minimum requirements/specifications must be provided by the firm.


The interested firm(s) are requested to submit Expression Of Interest (EOI) in a sealed envelope superscribed with "Expression of Interest for Active Directory (AD) Services and Patch Management for windows desktops and servers" to the AO(J) (IT/Stationery), Room No. 6, Ground Floor, LCB-III, Delhi High Court on or before 29-07-2020 till 5:00 P.M. clearly mentioning the technical details of the product being offered. The Expression of Interest (EOI) should be addressed in the name of "The Registrar General, Delhi High Court, New Delhi" and the subject of this letter & due date be superscribed on the envelope. EOI received **without subject & due date** mentioned above, shall be summarily rejected. EOI received **after due date** in IT/Sty. branch shall also be summarily rejected.

The firm(s) will have to give live demo of the solution suggested by them before the authorities in Delhi High Court. The firms are required to submit their technical and financial bids in separate sealed envelopes placed in a separate single sealed cover. The High Court reserves the right to alter/amend the scope of work at a later stage based on its requirement. Delhi High Court also reserves the right to award the work fully/partly to different firms.

Financial Bids of only those firms shall be opened whose technical bids are found suitable as per the requirement of this Court. The validity of rates should not be less than 180 days from the last date of submission of Expression of Interest and the taxes/GST applicable should be clearly mentioned. Financial Bids with **less period of validity of rates shall be summarily rejected**. The firm shall submit a certificate to the effect that the firm has not been **debarred/black-listed** by any Government/Semi-Government Organization in India, failing which the EOI of the firm shall be rejected.

The selected firm(s) shall carry out the implementation of Active Directory (AD) services and Patch Management for windows desktops and servers and thereafter onsite support should be provided for a period of five (05) years after implementing Active Directory (AD) services and patch management for windows desktops and servers alongwith availability of two onsite engineers both L1 and L2 from 8 A.M. To 8 P.M.
