This Court intends to purchase Microsoft Surface Pro 8, Intel Core i7 processor (11th Generation), 16 GB RAM, 256 GB SSD, latest Windows Operating System, Surface Pro Signature keyboard and compatible pen with three years warranty for the use of Hon'ble the Chief Justice and Hon'ble Judges of this Court.

The terms & conditions of this tender are as under:

- 1. The firm(s)/vendor(s) (Based in Delhi/NCR Region only) authorized by OEM are requested to submit the necessary sealed quotation(s) offering the rates for Microsoft Surface Pro 8, Intel Core i7 processor (11th Generation), 16 GB RAM, 256 GB SSD, latest Windows Operating System, Surface Pro Signature keyboard and compatible pen with three years warranty with copy of current valid authorization letter issued by the OEM in their favour.
- 2. Sealed envelopes containing the quotations referred to above must reach to the AOJ (IT & Stationery Branch), Lawyers' Chamber Block-III, Room No. 6, Ground Floor, Delhi High Court on or before 1066 2022 till 5:30 P.M.
- 3. The envelope should be addressed in the name of "The Registrar General, Delhi High Court. New Delhi."
- 4. The subject "Quotation for purchase of Microsoft Surface Pro 8 (11th Gen.) with accessories" and due date of Tender should be superscribed on the envelope.
- 5. The validity of rates should not be less than 180 days from the last date of submission of quotation.
- 6. Quotations with less period of validity of rates shall be summarily rejected.
- 7. The quotations must be tendered strictly in the format mentioned in **Annexure 'A'** of this tender. Quotations offered in any other format than prescribed shall be liable to be rejected.
- 8. The firms/vendors offering NET rate, (rate without tax component) claiming that they are mandatorily not required to be registered under the GST Act shall submit NET rates only in their quotation and need not mention tax rate/ tax amount and are further required to submit supporting documents in support of exemption from registration

- under GST Act viz. CA's Certificate, Copy of Notification issued by Govt of India/Govt of NCT of Delhi duly attested under the seal of the firm to this effect with the quotation and certificate issued by Charted Accountant for the F.Y. 2021-2022 & 2022-2023 etc.
- 9. The vendors exempted from Registration under GST Act shall also submit Affidavit on a non-judicial stamp paper of Rs.10/- affixed with Rs. 5/- Notarial Stamp duly notarized by Notary Public as per **Annexure 'B'**.
- 10. No quotations shall be entertained after due date. Envelope(s) without subject having been mentioned on them shall be summarily rejected.
- 11. The selected eligible L-1 firm vendor shall be bound to supply the required item within ten (10) days from the date of issuance of Purchase Order, failing which the purchase order issued shall be deemed to be cancelled without entertaining any communication in this regard unless sufficient cause is shown (supported by documentary proof) for such delay.
- 12. In case the Purchase Order awarded to the eligible L-1 firm is cancelled due to non-supply of goods within stipulated period, the Purchase Order will be awarded to the next eligible L-2 vendor/firm.
- 13. If multiple quotations are submitted for the instant Tender by a firm/vendor, all such quotations submitted shall be liable to be rejected at the first instance.
- 14. The firm or vendor shall also have to give an undertaking (as per **Annexure 'C'**) that the firm or its Partner/Director/Proprietor has not been blacklisted/banned and its Business dealings with the Central/State Government/Public Sector Undertakings/ Autonomous Bodies have not been banned/terminated on account of poor performance/conduct and also that all the terms and conditions of the instance Tender Notice are acceptable to them. The quotations received without undertaking shall be summarily rejected.
- 15. After opening of the sealed quotations, if any correction is found in the offered rate which renders the whole Tender process doubtful or ambiguous, the said quotation shall be summarily rejected.
- 16. Withdrawal of quotation(s) after their opening may attract blacklisting of the firms/vendor for participation in any future tender process of this Court for a period of six months from the date of blacklisting.

This Court reserves the right to modify/ amend the instant Tender, its terms & conditions at a later stage.
