## Sub: Tender calling quotation(s) for purchase of one hundred (100) nos. of 16GB DDR4 RAMs of reputed make with 3 years or more warranty compatible with presently installed two models of desktops i.e. HP 280 GN and HP 280 G4 MT .

This Court intends to purchase one hundred (100) nos. of 16GB DDR4 RAMs of reputed make with 3 years or more warranty to be installed in HP 280 GN and HP 280 G4 MT Desktops presently being used in this Court.

#### The terms & conditions of this tender are as under:

- 1. Interested firms/vendor(s) authorized by OEM are requested to submit the necessary quotation(s) along with the undertaking that the RAMs proposed to be supplied are compatible with above mentioned desktops & their installation will not breach the warranty of desktops and copy of current authorization letter of the OEM (whose product is being offered) and Earnest Money Deposit (EMD) of 5% of total proposed cost for purchase of one hundred (100) nos. of 16GB DDR4 RAMs by way of Demand Draft or Bankers Cheque drawn in favour of "The Registrar General, Delhi High Court" payable at New Delhi.
- 2. Quotations received without EMD shall be summarily rejected and no request for waiver will be entertained.
- 3. Selected firm/vendor will also be required to submit valid authorization letter or copy of valid Authorization letter issued by OEM in their favour while submitting Invoice/Bill mentioning warranty/support period.
- 4. Sealed envelope containing the quotation, EMD and authorization letter must reach to the AOJ (IT & Stationery Branch), Lawyers' Chamber Block-III, Room No. 6, Ground Floor, Delhi High Court on or before <u>[7]5/2022\_1</u> till 5:30 P.M. clearly mentioning the rates inclusive of GST /Tax rate, technical specification of the product, warranty/support period and the delivery schedule of the product being offered.
- 5. The envelope(s) should be addressed in the name of "The Registrar General, Delhi High Court, New Delhi" and the subject "Quotation for one hundred (100) nos. of 16GB DDR4 RAMs" should be superscribed on the envelope.
- 6. The validity of rates should not be less than 180 days from the last date of submission of quotations and tax rate applicable should be clearly & separately mentioned.
- 7. Quotations with less period of validity of rates shall be summarily rejected.
- 8. No quotations shall be entertained <u>after due date</u>. Envelope(s) <u>without subject</u> <u>having been mentioned on them shall be summarily rejected</u>.
- The quotations must be tendered strictly in the format mentioned in Annexure 'A' of this tender. Quotations offered in any other format than prescribed shall be liable to be rejected.
- The DD/Pay order towards EMD of all the tenderers, except the lowest three, shall be returned to vendors on their written request after finalization of Tender Process & EMD of successful tenderer will be returned only after supply and successful

installation of the first order placed to the successful firm fulfilling all codal, formalities against receipt.

- 11. The DD/Pay Order of L-2 & L-3 will be returned upon written request after issuance of the Purchase order to the successful tenderer. If the offer of quotation is withdrawn by the bidder before/after opening of tender or any other default, the amount of EMD shall be forfeited and the firm will be blacklisted from participation in future tenders of this Court.
- 12. The firms/vendors offering NET rate (rate without tax component) claiming that they are mandatorily not required to be registered under the GST Act shall submit NET rates only in their quotation and need not mention tax rate & amount and are, further required to submit supporting documents in support of exemption from registration under GST Act viz. CA's Certificate for the F.Y.2020-21 of 2021-22, the latest Copy of Notification issued by Govt of India/Govt of NCT of Delhi duly attested under the seal of the firm to this effect with the quotation. The vendor exempted from Registration under GST Act shall also submit Affidavit on Rs.10/non-judicial stamp paper affixed with Rs.5/- Notarial Stamp duly notarized by Notary Public as per Annexure 'B'.
- 13. The selected eligible L-1 firm shall be bound to supply the required item within twenty one (21) days from the date of issuance of Purchase Order, failing which the purchase order issued shall be deemed to be cancelled without entertaining any communication in this regard unless sufficient cause is shown (supported by documentary proof) for such lapse.
- 14. In case the Purchase Order awarded to the eligible L-1 firm cancelled due to nonsupply of goods within the stipulated period, the Purchase Order will be awarded to the next eligible L-2 vendor/firm.
- 15. If multiple quotations are submitted by a firm/vendor, all such quotations submitted shall be liable to be rejected at the first instance.
- 16. After opening of the sealed quotation(s) if any correction is found in the offered rate, which renders the whole Tender process doubtful or ambiguous, the said quotation shall be summarily rejected.
- 17. The firm/vendor shall also have to give an undertaking (as per Annexure- 'C') that the firm cr its Partner/Director/Proprietor has not been blacklisted/banned and its Business dealings with the Central/State Government/Public Sector Undertakings/Autonomous Bodies have not been banned/terminated on account of poor performance/conduct and also that all the terms and conditions of the instant Tender Notice are acceptable to them. The quotation received without undertaking shall be summarily rejected.

This Court reserves the right to modify/amend the quotation letter/terms & conditions at a later stage and to increase or decrease the quantity depending on the requirement.
