The quotations should be addressed in the name of "The Registrar General, Delhi High Court, New Delhi" and the subject of this letter be superscribed on the envelope. Quotation received without subject mentioned above and without DD/Pay order towards refundable EMD as referred above shall be summarily rejected. The selected vendor(s) will have to give demo of the products offered by them.

The DD/Pay order towards EMD of all the tenderers, except the lowest three, shall be returned against receipt. If the offer of quotation withdrawn by the tenderer after opening of tender or any other default, the amount of EMD will be forfeited.

The final rates offered for products should be inclusive of all taxes and clearly mentioning the warranty period/authorization from the OEM in the quotation. The taxes applicable should also be clearly and separately mentioned. The validity of rates should not be less than six months from the last date of submission of quotation. Quotation with less period of validity of rates shall be rejected.

The quotations received after due date shall be summarily rejected.
