The envelope should be addressed in the name of "The Registrar General, Delhi High Court, New Delhi" and the subject of this letter & due date be superscribed on the envelope. Quotation received without subject & due date mentioned above, and without DD/Pay order towards refundable EMD, as referred above, shall be summarily rejected.

The DD/Pay order towards EMD of all the tenderers, except the lowest three, shall be returned against receipt. If the offer of quotation is withdrawn by the tenderer after opening of tender or any other default, the amount of EMD will be forfeited and the firm will be blacklisted to participate in future tenders of this court.

The final rates offered for Desktops should be inclusive of all taxes and the warranty period/carepack from manufacturer should be clearly mentioned in the quotation. The taxes applicable should also be clearly and separately mentioned. The validity of rates should not be less than six months from the last date of submission of quotation. Quotation with less period of validity of rates shall be rejected.

The quotations received after due date shall be summarily rejected.

This Court reserves the right to modify/amend the quotation letter/terms and conditions at a later stage. This Court also reserves the right to increase or decrease the number of desktops, at a later stage
