Quotation without EMD shall be summarily rejected and no request for waiver will be entertained.

The DD/Pay order towards EMD of all the tenderers, except the lowest three, will be returned to vendors on their written request after finalization of Tender Process & EMD of successful tenderer will be returned after supply and successful installation of the order placed to the firm/after fulfilling all codal formalities.

The DD/Pay Order of L-2 & L-3 will be returned after awarding the work order to the successful tenderer. If the offer of quotation is withdrawn by the tenderer before/after opening of tender or any other default, the <u>amount of EMD shall be forfeited</u> and the <u>firm will be blacklisted</u> to participate in future tenders of this Court.

On successful testing of the supplied UPS with the devices being used in this Court, purchase order will be placed on the successful vendor.

This Court reserves the right to modify/amend the quotation letter/terms and Conditions at a later stage. This Court also reserves the right to place the Order fully/partly to different firm(s)/vendor(s). It may be noted that final rates should be mentioned inclusive of GST.
