Note:- New switches will have to be integrated with existing Cisco core L3 Switches/LAN by the selected vendor.

The Authorized Vendors of CISCO are requested to submit the quotations in a sealed envelope to the AO (J), Information Technology & Stationery Branch, Lawyers' Chamber Block-III, Ground Floor, Delhi High Court on or before 16-03-2020 clearly mentioning the make/model/features/configurations of the product(s) being offered. The validity of rates should

not be less than 180 days from the last date of submission of quotation and the taxes applicable should be clearly and separately mentioned. Quotations with less period of validity of rates shall be summarily rejected.

Further, the successful vendor will have to <u>execute proper service agreement</u> with this Court and also submit <u>Performance Bank Guarantee</u> valid for five years from the date of successful installation of all the hardware/software (if any) of the value of 8% of the Invoice Amount including taxes. The quotations to be submitted by the authorized vendor(s) only alongwith Demand draft/Pay order of the value of 5% of total amount of aforesaid work in favour of "The Registrar General, Delhi High Court, New Delhi-110503" towards <u>earnest money deposit (EMD) (refundable without interest on written request after finalization of Tender Process)</u>. No request for waiver of EMD shall be entertained.

Quotation received without subject mentioned above variable and without DD/Pay order towards EMD as referred above shall be summarily rejected.

The DD/Pay order towards EMD of all the tenderers, except the lowest three, will be returned to vendors on their written request after finalization of Tender Process & EMD of successful tenderer will be returned after supply and successful installation of the order placed to the firm/after fulfilling all codal formalities & acceptance of the **Performance Bank Guarantee**.

The DD/Pay Order of L-2 & L-3 will be returned after awarding the work order to the successful tenderer. If the offer of quotation is withdrawn by the tenderer before/after opening of tender or any other default, the amount of EMD shall be forfeited and the firm will be blacklisted to participate in future tenders of this Court.

The final rates offered for the active & passive items should be mentioned as unit price of each item inclusive of all taxes and clearly mentioning the warranty period and authorization certificate from concerned OEM in quotation against each item. The taxes applicable should also be clearly and separately mentioned.

This Court reserves the right to modify/amend this quotation letter/terms and conditions at a later stage. This Court also reserves the right to place the order fully/partly to different firms/vendors. This Court also reserves the right to use the LAN points/passive items rates for installation of items in earlier LAN network installed by other vndors.
