Terms & Conditions of this tender are as under:-

- 1. The validity of rates should not be less than 180 days from the last date of submission of quotations. Quotations with less period of validity of rates are liable to be summarily rejected.
- 2. The successful firm shall be awarded the tender at the quoted/approved rates. In case the firm which has been awarded the tender refuses to supply the required goods at the

- quoted rates during the said period of 180 days, the firm shall be liable to be blacklisted for participating in future tenders of this Court.
- 3. No quotation shall be entertained <u>after due date</u>. Quotations <u>without the subject as</u> <u>referred to above & due date having been mentioned on the envelope</u> liable to be summarily rejected. Quotations received after due date shall be summarily rejected.
- 4. The firm(s)/vendor(s) must submit only one quotation against instant Tender Notice. Submission of more than one quotation(s) shall be liable to be rejected. Quotation(s) related to some other item(s) not related to instant tender placed in the sealed/closed envelope shall be liable to be rejected.
- 5. After opening of the sealed/closed envelope(s), if any correction is found in the offered rate, which renders the whole Tender process doubtful or ambiguous, the said quotation shall be summarily rejected.
- 6. The quotations must be tendered strictly in the format mentioned in <u>Annexure 'A'</u> of this tender notice. Quotations offered in any other format than prescribed shall be liable to be rejected.
- 7. The selected L-1 vendor/firm shall be bound to supply the required item within 10 days from the date of issuance of Purchase Order, failing which the Purchase Order shall be deemed to be cancelled without entertaining any communication in this regard unless sufficient cause is shown (supported by documentary proof) for such delay.
- 8. In case the Purchase Order awarded to L-1 firm is cancelled due to non-supply of goods within the stipulated period, the Purchase Order will be awarded to the next eligible L-2 vendor/firm.
- 9. The acceptance of supplied item(s) in the Stationery Store of Delhi High Court shall be subject to codal formalities viz., inspection by an independent officer nominated for the purpose.
- 10. - 12. Withdrawal of quotation(s) or seeking revision of rates on any ground, after their opening may attract blacklisting of the firm/vendor from participation in any future tender processes of this Court for a period of six months from the date of blacklisting.
- 13. This Court reserves the right to award the tender fully or partly to different firm(s)/vendor(s).
- 14. This Court reserves the right to modify/amend the quotation letter/Terms and Conditions at a later stage and to increase or decrease the quantity depending on the requirement.
