Note:-

- 1. The judicial officers shall be under the control of the Principal District & Sessions Judge of the district, to which they have been allocated.
- 2. The judicial officers under transfer shall notify the cases in which they had reserved judgments/orders before relinquishing the charge of the court in terms of the posting/transfer order. The judicial officers shall pronounce judgments/orders in all such matters on the date fixed or maximum within a period of 2-3 weeks thereof, notwithstanding the posting/transfer. Date of pronouncement shall be notified in the cause list of the court to which the matter pertains as also of the court to which the judicial officer has been transferred and on the website.
- 3. The Principal District & Sessions Judge, (Central) Tis Hazari, shall withdraw sufficient number of cases from the existing courts of District Judges (Commercial Court) and assign them to the newly created court of District Judge (Commercial Court)-07 and (Commercial Court)-08, so as to ensure equal pendency.
- 4. The Principal District & Sessions Judge (West) Tis Hazari shall withdraw sufficient number of cases from the existing courts of District Judges (Commercial Court) and assign them to the newly created court of District Judge (Commercial Court)-03, so as to ensure equal pendency.
- 5. The court of District Judge (Commercial Court), North West Rohini, presided over by Sh.Gurdeep Singh is henceforth re-designated as District Judge (Commercial Court)-01, North West Rohini.
- 6. The Principal District & Sessions Judge (North West) Rohini shall withdraw sufficient number of cases from the existing court of District Judge (Commercial Court) which is redesignated as District Judge (Commercial Court)-01 and assign them to the newly created court of District Judge (Commercial Court)-02, so as to ensure equal pendency.
- 7. The Principal District & Sessions Judge, West, Tis Hazari, shall withdraw sufficient number of Rape cases from the existing courts and assign them to the newly created court of ASJ(SC-RC) which is a special court for rape cases, so as to ensure equal pendency.

- 8. The Principal District & Sessions Judge, West, Tis Hazari, shall withdraw sufficient number of POCSO cases from the existing courts of Addl.Session Judges (ASJs) in the District, and assign them to the newly created court of ASJ(SC-POCSO) which is a special court for POCSO cases, so as to ensure equal pendency.
- 9. Ms.Archana Beniwal (who is on Child Care Leave till 09.06.2023) mentioned at Serial No.47 shall preside over the court assigned to her, on her joining after availing the leave.
