ORDER

Whereas, vide this Court's order No.4109-4116/DHC/Gaz./G-7/VI.E.2(a)/2016 dated 29.09.2016, Ms. Rachna Tiwari Lakhanpal, an officer of Delhi Judicial Service was placed under suspension with immediate effect. Whereas, by subsequent orders her suspension was extended from time to time and lastly her suspension was extended for a further period of 120 days beyond 23.07.2023.
