# **INVITING APPLICATIONS FOR EMPANELMENT**

Applications are invited from eligible members of the High Court of Delhi Bar Association, for empanelment on the following legal aid panels of the High Court of Delhi (Middle Income Group) Legal Aid Society.

High Court of Delhi (Middle Income Group) Legal Aid Society is a Society registered under the Societies Registration Act, which has been formed with an objective to provide legal aid to Middle Income Group, which, as defined, comprise of persons having annual income between Rs 60,000/- to Rs 7,00,000/-, in relation to the legal issues pertaining to the litigation in Hon'ble Delhi High Court.

The Society is an autonomous body and is currently presided by Hon'ble Justice G.S.Sistani.

#### **Brief Instructions**

Panels: Criminal, General Civil Laws, Family/Matrimonial Laws and Service/Labour Laws

Eligibility: Advocate members of the Delhi High Court Bar Association with minimum 3

years of experience are eligible to apply. There will be two age group panels for each category of the aforesaid panels. (i) 3-10 years and (ii) 10 years and above

experience.

Selection: Shortlisted applicants will be called for a brief interaction with the Selection

Panel of the Society, to assess the general suitability of the applicants. Selection

Panel(s) will comprise of members of the Executive Council of the Society.

Each panel shall comprise of 30 advocates. Only such eligible applicants who are found suitable by the selection panel will be empanelled. Decision of the

Selection Panel will be final.

An applicant can apply for empanelment only in 1 panel.

Term: Empanelment shall be for a period of 3 (three) years.

Fee: Empanelled advocates shall be paid fee for their servicesas per the fee

schedule and rules of the Society.

- (ii) Advocates already empaneled with any legal services authority shall not eligible for empanelment.

# Panels:

- (iii) There will be two age group panels for each category i.e3-10 years and 10 years and above, experience. Each panel will have 30 advocates
- An applicant is eligible to apply for only ONE panel. Applications (iv) with more than one choice of panel exercised shall be rejected.
