The judicial officers shall be under the control of the Principal District & Sessions Judge of the district to which they have been allocated.

The judicial officers under transfer shall notify the cases in which they had reserved judgments/orders before relinquishing the charge of the court in terms of the posting/transfer order. The judicial officers shall pronounce judgments/orders in all such matters on the date fixed or maximum within a period of 2-3 weeks thereof, notwithstanding the posting/transfer. Date of pronouncement shall be notified in the cause list of the court to which the matter pertains as also of the court to which the judicial officer has been transferred and on the website.

- The Principal District & Sessions Judge-cum-Special Judge (PC Act)(CBI), RACC shall take steps for assignment of cases to the newly created Labour Courts of PO Labour Court-07, PO Labour Court-08 and PO Labour Court-09.

The Principal District & Sessions Judge (HQ), THC shall assign the cases under the POCSO Act from the court of ASJ-05(POCSO), Central THC to the two newly created courts of ASJ(FTSC)(POCSO) -01 and ASJ(FTSC)(POCSO) -02 (which are Special Courts for trial of cases under the POCSO Act) and the other cases to other courts of competent jurisdiction, so as to ensure equal pendency. The Principal District & Sessions Judge (HQ), THC shall also withdraw sufficient number of cases from the court of ASJ-01 (POCSO) and assign them to the said new courts, so as to ensure equal pendency.
- The Principal District & Sessions Judge (HQ), THC shall withdraw sufficient number of rape cases from the court of ASJ (Special Fast Track Court) presided over by Mr. Satish Kumar and assign them to the newly created court of ASJ(FTSC)(RC), Central, THC so as to ensure equal pendency.
- 7. The Principal District & Sessions Judge (HQ), THC shall withdraw sufficient number of cases from the existing courts of ASJs in the district and assign them to the newly created court of ASJ-05, Central, THC so as to ensure equal pendency.
- The court of Special Judge, Electricity Court presided over by Mr. Vidya Prakash shall be re-designated as Special Judge, Electricity Court-01, Central, THC. The Principal District & Sessions Judge, North, Rohini shall assign the cases under the POCSO Act in the Court of ASJ-06(POCSO), North, Rohini to the newly created court of ASJ(FTSC)(POCSO) (which is a Special Court for trial of cases under the POCSO Act) and the other cases to other courts of competent jurisdiction, so as to ensure equal pendency.
- The Principal District & Sessions Judge, North, Rohini shall withdraw sufficient number of cases from the existing courts of ADJs in the district and assign them to the newly created court of ADJ-04, North, Rohini so as to ensure equal pendency.
- 22. The courts of ASJ-04(POCSO), South-West, Dwarka hitherto presided over by Mr. Pritam Singh and ASJ-05(POCSO), South-West, Dwarka hitherto presided over by Ms.Gomati Manocha stand abolished. The Principal District & Sessions Judge, South-West, Dwarka shall assign the cases under the POCSO Act from the said courts to the three newly created courts of ASJ(FTSC)(POCSO)-01,ASJ(FTSC)(POCSO)-02 and ASJ(FTSC)(POCSO)-03 (which are Special Courts for trial of cases under the POCSO Act) and the other cases to other courts of competent jurisdiction, so as to ensure equal pendency.
- The Principal District & Sessions Judge, South-West, Dwarka shall withdraw sufficient number of rape cases from the ASJ (Special Fast Track Court), South-West, Dwarka (presently vacant) and assign them to the newly created court of ASJ(FTSC)(RC), so as to ensure equal pendency.

- The Principal District & Sessions Judge, South-West, Dwarka shall withdraw sufficient number of cases from the existing courts of ASJs in the district and assign them to the newly created court of ASJ-04, South-West, Dwarka and ASJ-05, South-West, Dwarka so as to ensure equal pendency.
- The court of PO(MACT), South-West, Dwarka presided over by Mr.Sumedh Kumar Sethi is re-designated as PO(MACT)-01, South-West, Dwarka. The Principal District & Sessions Judge, South-West, Dwarka shall withdraw sufficient number of cases from the said court and assign them to the newly created court of PO(MACT)-02, South-West, Dwarka, so as to ensure equal pendency, under intimation to this Court.
