NOTES:-

- 1. The judicial officers shall be under the control of the District & Sessions Judge of the District to which they have been allocated.
- 2. The judicial officers under transfer shall notify the cases in which they had reserved judgments/orders before relinquishing the charge of the court in terms of the posting/transfer order. The judicial officers shall pronounce judgments/orders in all such matters on the date fixed or maximum within a period of 2-3 weeks thereof, notwithstanding the posting/transfer. Date of pronouncement shall be notified in the cause list of the court to which the matter pertains as also of the court to which the judicial officer has been transferred and on the website.
- 3. The concerned District & Sessions Judge will ensure that the proper track is kept about

- movement of cases from transferor court(s) to transferee court(s) due to above postings/transfers and no inconvenience is caused to the lawyers and litigants in transfer of cases, which shall be duly notified on the website of District Courts as also outside the transferor court(s).
- 4. The concerned District & Sessions Judge will assign sufficient number of cases to the newly created courts as above on withdrawal from other courts of the said District ensuring equal distribution except where the work is specifically assigned as above.
- 5. The District & Sessions Judge, New Delhi, PHC shall assign cases to the Court of ACMM-2, New Delhi, PHC in order to ensure equitable distribution of workload.
- 6. The Court being presided over by Ms. Vasundhra Chhaunkar MM (Mahila Court), New Delhi, stands redesignated as MM (Mahila Court)-1, New Delhi, PHC.
- 7. The Court henceforth presided over by Ms. Jyoti Maheshwari MM (NI Act), New Delhi, PHC stands redesignated as MM (NI Act)-1, New Delhi, PHC.
- 8. The Court henceforth presided over by Ms. Anuradha Prasad, Civil Judge, South-East District, Saket stands redesignated as Civil Judge-1, South-East, Saket.
- 9. The existing PS Shakarpur in East District shall henceforth be referred to by its new name PS Laxmi Nagar.
- 10. The cases u/s 138 Negotiable Instruments Act involving "Financial Institutions" [which expression shall include "financial institutions" within the meaning of SARFESI Act, 2002 (The Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002), Nationalized Banks including State bank of India and "banking companies" within the meaning of Banking Regulation Act, 1949] shall form a separate category and shall be tried by the courts of MM (NI Act-FI) set-up at Rouse Avenue District Court Complex. All cases under Section 138 Negotiable Instruments Act of the said category pertaining to jurisdiction of all the Districts except South-West District, Dwarka shall be withdrawn by the District & Sessions Judges from the respective courts and transferred to CMM, Rouse Avenue District Court Complex, who shall henceforth assign them to the courts of MM (NI Act-FI) at that location for further proceeding in accordance with law. All fresh criminal complaints of the abovesaid category of cases pertaining to all the Districts/court complexes in Delhi except South-West District/Dwarka Court Complex shall be presented before the CMM, Rouse Avenue District Court Complex and shall be assigned and tried by the courts of MM (NI Act-FI) in the said court complex.
- 11. The other criminal complaints u/s 138 Negotiable Instruments Act (i.e. other than those mentioned in the preceding note no.10) shall continue to be dealt with in the Courts where they are presently pending till they are allocated/transferred as per administrative exigencies of the particular location. All fresh cases of such nature shall be presented before the concerned CMM who may allocate the same to the Courts of MM (NI Act) under their respective control.
- 12. The District & Sessions Judges, shall withdraw cases u/s 138 Negotiable Instruments Act (other than those mentioned in preceding note no.10) from the Courts of CMM, ACMM and other general MMs/Civil Judges and distribute them to the newly created courts of MM (NI Act), in order to ensure equitable distribution of workload.
- 13. The District & Sessions Judges shall assign sufficient number of civil cases to the newly created courts of Civil Judges in their respective Districts on withdrawal from other such Courts in order to ensure equitable distribution of workload.
- 14. The District & Sessions Judges shall withdraw all cases triable by Courts of Metropolitan Magistrates initiated by the CBI from the courts of CMM/ACMM/MMs in their respective jurisdictions and transfer the said cases to the Court of CMM at the Rouse Avenue District Court Complex who may retain the same in his/her Court or allocate for further proceeding in accordance with law to ACMM-02-cum-ACJ at the said location.
- 15. The District & Sessions Judge of each Sessions Division shall issue orders distributing the work of MM (Mahila Courts) amongst each such Court (where there is more than one such Court in the District) specifying the Police Stations for purposes of fresh cases registered or instituted henceforth to ensure equitable distribution, under intimation to this court.
- 16. The District & Sessions Judges while making compliance with the directions in the preceding note, shall also withdraw sufficient number of existing cases bearing in mind the above, from

the existing Court of MM (Mahila Court) and assign them to the newly set up MM (Mahila Court), in order to ensure equitable distribution of workload.

- 17. The Special Court at the Magisterial level dealing with the cases of MPs/MLAs in Patiala House Court Complex presided over by Mr. Samar Vishal shall start functioning from the Rouse Avenue Court Complex and is redesignated as the court of ACMM-1, Rouse Avenue District Court Complex.
- 18. The officers of Delhi Judicial Service who have completed their Induction Training shall be attached to the Courts to which they have been posted and those who have been posted to new Courts shall be attached with Courts of similar jurisdiction in the respective Districts till 08.04.2019. The concerned District & Sessions Judges of the respective Districts, in which such new Courts have been created, shall pass an appropriate order regarding the attachment of such officers.
- 19. The work arising out of investigation of cases of new police stations created vide Govt. of NCT of Delhi Notification dated 31.12.2018 shall be assigned to the courts of Metropolitan Magistrates (in addition to the work already assigned to them) as under:
