OR CODE-BASED DIGITAL ENTRY PASS SYSTEM

It is hereby informed to all concerned that, in addition to the present system of entry into the

Court Blocks, Delhi High Court, QR code-based digital entry pass system is also going to be

made operational, on experimental basis, with effect from 25.01.2021 as per under mentioned

SOP.

A) ISSUANCE OF QR CODE-BASED DIGITAL ENTRY PASS FOR ATTENDING

PHYSICAL HEARINGS

The QR code-based digital entry pass (QR Pass) shall be generated and issued digitally by the

High Court Registry one day in advanceon the basis of listing of cases before the Hon'ble

Benches holding physical hearings.

B) DELIVERY OF QR PASS

The QR Pass will be received by all the concerned Advocates/Parties-in-person, who have got

their mobile number(s) and email IDs registered in Case Information System of Delhi High

Court. The QR pass shall be sent as attachment (PDF file) through email & SMS.

C) MANNER OF USING THE QR CODE PASS

The concerned Advocate/Party-in-person shall be required to download the attached digital entry

pass (PDF file) on her/his Mobile/Laptop/Tablet/iPad from the email or SMS link, and show

such downloaded QR Pass to the security personnel at the Entry Gate(s) of respective court

building(s) while entering and while making exit. Generally, there shall not be any requirement

of generating any printout of such QR Pass.

D) VALIDITY OF QR CODE PASS

The QR Pass shall be valid for the day for which it is issued and can be used only once that day.

The security personnel deployed at Entry Gate(s)/Exit Gates(s)shall use QR code reader to get

the details of the visiting Advocate/Party-in-person.

E) PROOF OF IDENTITY

The concerned Advocate/Party-in-person also need to carry anyoriginal ID Proof(Bar

Council/Bar Association Card/government ID) along with the QR Passat the time of entryinto

the Court Block(s).

F) DELEGATION OF QR PASS

The concerned Advocateshall ensure that the QR Pass is not misused by anyone. Such QR Pass

is non-transferrable. However,in case the concerned Advocateis not in a position to attend the

Court proceedings and wantssome other advocate to represent her/him before theHon'ble Court,

then she/he shall issuenecessary authorization in writing. Such authorization along with copy ofher/his ID and printout of QR Pass shall be provided to the authorized advocate to be shown at the time of entry. Such authorized advocate shall be permitted entry after due verification. The written authorization shall be retained for record at the time of entry.

G) GENERAL

As already notified, the system of hybrid hearing is presently at the testing stageand, therefore, wherever any Advocate is unable to appear before the Hon'ble Court on physical days and provides advance intimation to that effect to the concerned Court Master, the matter shall be suitably adjourned as per the directions of the Hon'ble Court. As and when the hybrid system is made functional in all the courtrooms, due intimation with further appropriate directions shall be uploaded on the website.

All the Advocates, litigants and other visitors are requested to strictly adhere to the norms of social distancing and other Covid-19 related guidelines issued by Govt. of India/Govt. of NCT of Delhi.
