Notes:-

- 1. Since division of Delhi into 11 districts/sessions divisions/metropolitan areas is coming into force with these postings/transfers and pending work of some jurisdictions is being transferred from courts existing prior to these changes, the District & Sessions Judges are required to co-ordinate with each other, inter alia, with the assistance from the Chief Metropolitan Magistrate and concerned ACMMs and Senior Civil Judges to ensure smooth transition. Suitable steps shall be taken to inform the lawyers, litigants, parties and other persons concerned about the shiftings/transfers of courts.
- 2. The District & Sessions Judges will ensure that proper track is kept about movement of cases from transferor court(s) to transferee court(s) due to above postings/transfers and no inconvenience is caused to the lawyers and litigants in transfer of cases, which shall be duly notified well in advance on the website of district courts as also outside the transferor and transferee court.
- 3. The existing District & Sessions Judges will ensure that the work is assigned to the courts as above so that the newly created courts/transferee courts can start functioning without delay.
- 4. The Judicial Officers under transfer shall pronounce the judgments/orders in the cases in which they had reserved judgments/orders before relinquishing the charge of the court in terms of the postings/transfers order, and in case any matter for pronouncement of judgment/order has been fixed beyond the effective date of postings/transfers order, then the said matter shall be preponed and the judgment/order shall be pronounced before relinquishing the charge of the court in terms of the postings/transfers order.
- 5. Fresh cases or matters shall be presented to, filed in or allocated in accordance with the jurisdiction assigned to the respective courts.
- 6. Such cases pending in the transferor/abolished courts, as have not been specifically assigned as above, shall be assigned by the concerned District & Sessions Judges to other courts of the competent jurisdiction so as to ensure equal pendency.
- 7. Criminal cases investigated by the CBI as are to be presented in the jurisdiction of the court of a Magistrate shall henceforth be entertained by the court of the CMM of the respective district/metropolitan area, who shall be competent to deal with the same himself/herself or assign the same to the court(s) ACMM(s) of the concerned district/metropolitan area, within his/her discretion, having regard to the workload of the court(s) of ACMM(s).
- 8. The courts of CMM assigned the work of particular district/metropolitan area shall also be the court to deal with the criminal matters arising out of the cases of respective district/metropolitan area investigated by the Crime Branch.
- 9. The courts of CMM assigned the work of particular district/metropolitan area shall be the courts to deal with the criminal matters involving Intellectual Property Rights, eg., cases under Copy Rights Act, Trademarks Act, Patents Act, etc. within their respective jurisdiction, who shall themselves deal with the same or assign the same to the ACMM(s) of the respective district/metropolitan area, within their discretion, having regard to the work of the court(s) of ACMM(s).

- 10. The court of the CMM of the respective district/metropolitan area shall deal with the criminal cases under the Official Secrets Act, SARFAESI ACT, 2002, cases investigated by the Special Cell and Special Task Force of Delhi Police and such other agencies as are not specifically assigned to any particular magisterial court.
- 11. The court of CMM, Central, Tis Hazari shall be the court assigned the work of criminal cases arising out of court complaints under Section 195 r/w Section 340 Cr.P.C. made by the Hon'ble Supreme Court of India, High Court of Delhi and the courts under the jurisdiction of the Central district/metropolitan area.
- 12. The other courts of CMMs shall be the courts assigned the work of criminal cases arising out of court complaints under Section 195 r/w 340 Cr.P.C. made by the courts of the respective district/metropolitan area.
- 13. The District & Sessions Judges may re-adjust the workload of the courts of Metropolitan Magistrates within each district/metropolitan area so as to bring about equitable distribution of work at each location.
- 14. The District & Sessions Judges may re-adjust the workload of civil courts under their respective control so as to bring about equitable distribution of work in each district.
- 15. The courts with respect to eleven civil districts created vide notification dated 17.10.2012 issued by the Govt. of NCT of Delhi and the Courts of Sessions and the courts of Metropolitan Magistrates for the cases of police stations under the jurisdiction of 11 sessions divisions and metropolitan areas created vide notifications dated 11.9.2012 and 17.10.2012, respectively, issued by the Govt. of NCT of Delhi, will function from the places/court complexes as under:-
