RE: DESIGNATION OF SENIOR ADVOCATE

In continuation of this Court's notice dated 26.04.2019 whereby applications have been invited from eligible Advocates for being designated as Senior Advocates, it is notified for all concerned that certain provisions of *High Court of Delhi Designation of Senior Advocate Rules, 2018* have been challenged by way of Writ Petition Nos. 4252/2019 and 483**8**/2019. The said writ petitions came up for preliminary hearing on 15.05.2019 before a Division Bench of this Hon'ble Court and after hearing the learned counsel for the parties, the Hon'ble Court has been pleased to passed the following order:-

> "Issue notice. Mr. Viraj R. Datar, learned counsel accepts notice for the respondent. Learned counsel for the petitioners requests that prayer (c) be deleted. Accordingly prayer (c) stands deleted from the writ petition.

> As an interim measure, we direct that applications submitted by Advocates desirous of being designated as Senior Advocates even if submitted without recommendations by Senior Advocates as otherwise required by Rules, should be accepted, subject to their fulfilling all other conditions contained in the Rules.

> We further direct the Registrar General of this Court to place the grounds raised in the writ petitions and the counter affidavit before the Full Court for consideration; and report back to us on the outcome of the consideration by 27.05.2019.

We also direct the Registrar General to issue a public notice informing all concerned about the present order; and that applications for designation are being received without necessity of recommendations at this stage, without however any change in the last date for receiving applications.

List on 27.05.2019".

In compliance with the aforesaid order, it is, therefore, notified for all concerned that henceforth applications for designation of Senior Advocate are being received without recommendations by Senior Advocates as otherwise required by Rules at this stage, without however any change in the last date for receiving applications.

Therefore, all those eligible Advocates who are desirous to apply for designation as Senior Advocate may submit the application in the prescribed format (*Annexure 'A'*) to this Public Notice in the Secretariat of the Committee for being designated as Senior Advocate, latest by 4.30 PM on 25.05.2019 without recommendations of Senior Advocates at this stage. However, the other conditions as stipulated in the Rules shall remain in force.
