- 1. The District and Sessions Judges (HQ), East, North-East, Shahdara and West Districts shall withdraw all such cases as pertain to jurisdiction of Family Courts from criminal/civil courts under their control in their respective districts and make over the same to the concerned Principal Judge, Family Courts, who may allocate/distribute the same to his/her own Court and/or the other Family Court at same location, ensuring equitable distribution.
  - 2. The Family Court hitherto presided over by Mr. Deepak Jagotra stands abolished and he is repatriated to his parent cadre. The Principal Judges, Family Courts, North and North-West shall allocate/distribute the cases pertaining to the jurisdiction of Family Courts of their respective districts to their own court(s) and/or to the other Family Court(s) at the same location, respectively.
  - 3. The Family Courts hitherto presided over by Mr. K.S. Mohi and Ms. Madhu Jain stand abolished and they are repatriated to their parent cadre. The cases pertaining to the jurisdiction of the Family Court as relate to the South District hitherto looked after by them are assigned to the court of Mr. Rakesh Siddhartha, Principal Judge, Family Courts, South, Saket.
  - 4. The cases pertaining to the jurisdiction of the Family Court as relate to the South-East District hitherto looked after by Mr. K.S. Mohi and Ms. Madhu Jain are assigned to the court of Mr. Amar Nath, Principal Judge, Family Courts, South-East, Saket.
  - 5. Fresh cases or matters shall be presented to, filed in or allocated in accordance with the jurisdiction assigned to the respective courts.
  - 6. The District & Sessions Judges and Principal Judges, Family Courts will ensure that proper track is kept about movement of cases from transferor court(s) to transferee court(s) due to above postings/transfers and no inconvenience is caused to the lawyers and litigants in transfer of cases, which shall be duly notified well in advance on the website of district courts as also outside the transferor and transferee court.
