NOTICE

The Overseeing Committee of the Delhi High Court Mediation and Conciliation Centre (Samadhan) has decided to hold an Induction Mediation training workshop for advocates enrolled with Delhi High Court Bar Association, from 31st January - 2nd February, 2020 at the Heritage Village, Manesar, Gurgaon, Haryana.

Considering the new challenges of Mediation and to involve more members of the Delhi High Court Bar Association, the Overseeing Committee has decided that only those advocates may apply who will be able to give quality time to the cause of Mediation. They will conduct court - annexed mediation sessions only at Samadhan (Delhi High Court Mediation and conciliation Centre). They will also be required to give an undertaking that they will not conduct mediations at CAW Cells and / or any Government authorized mediation centre.

Accordingly, it becomes necessary that all applicants once selected and trained as Mediators in the above training programme will submit an undertaking that they will conduct court annexed mediations only at Samadhan.

Interested advocates having eight years or more standing at the Bar may submit their applications at the Reception Counter of Delhi High Court Mediation and Conciliation Centre, 4th Floor, Administrative Block, Delhi High Court from 06.01.2020 to 10.01.2020 between 10.00 am to 1.00 pm.

Applicants would be interviewed and assessed for suitability before selection for the mediation training workshop.

Submission of application or being called for interview and training would not, ipso facto, entitle an applicant to be placed on the approved panel of mediators of Samadhan.
