Notes:

- 1. Since division of Delhi into 11 districts/sessions divisions/metropolitan areas is coming into force with these postings/transfers and pending work of some jurisdictions is being transferred from courts existing prior to these changes, the District & Sessions Judges are required to coordinate with each other, inter alia, with the assistance from the Chief Metropolitan Magistrate and concerned ACMMs and Senior Civil Judges to ensure smooth transition. Suitable steps shall be taken to inform the lawyers, litigants, parties and other persons concerned about the shiftings/transfers of courts.
- 2. The District & Sessions Judges will ensure that proper track is kept about movement of cases from transferor court(s) to transferee court(s) due to above postings/transfers and no inconvenience is caused to the lawyers and litigants in transfer of cases, which shall be duly notified well in advance on the website of district courts as also outside the transferor and transferee court.
- 3. The Judicial Officers under transfer shall pronounce the judgments/orders in the cases in which they had reserved judgments/orders before relinquishing the charge of the court in terms of the postings/transfers order, and in case any matter for pronouncement of judgment/order has been fixed beyond the effective date of postings/transfers order, then the said matter shall be preponed and the judgment/order shall be pronounced before relinquishing the charge of the court in terms of the postings/transfers order.
- 4. Fresh cases or matters shall be presented to, filed in or allocated in accordance with the jurisdiction assigned to the respective courts.
- 5. The courts of District & Sessions Judges, North, Rohini; South-East, Saket; and Shahdara, Karkardooma, shall be the courts earmarked to deal with cases under the Public Premises Act, Essential Services Maintenance Act, and Essential Commodities Act of the respective jurisdictions and shall be the courts to hear appeals against the orders of MCD Appellate Tribunal in respect of properties situated in their respective jurisdictions.
- 6. The courts of District & Sessions Judges, North, Rohini; South-East, Saket; and Shahdara, Karkardooma, shall be Additional Rent Control Tribunals under the Delhi Rent Control Act, 1958 and shall exercise jurisdiction as such under the said law for the purposes of cases! pertaining to the jurisdiction of their respective districts.

- 7. The court of District & Sessions Judge, North, Rohini, shall also deal with all fresh civil and matrimonial cases of the said jurisdiction.
- 8. The courts of ADJ, South-East, Saket and ADJ, Shahdara, Karkardooma, shall deal with all fresh civil and matrimonial cases of the respective jurisdictions.
- 9. The courts of ASJ-1, North, Rohini and ASJ-1, Shahdara, Karkardooma shall be the earmarked court for dealing with cases of SEBI and TADA/POTA/MCOCA of the respective jurisdictions.
- 10. The courts of ASJ-2, North, Rohini and ASJ-2, Shahdara shall be the earmarked court for dealing with cases of SC/ST Act of their respective jurisdictions.
- 11. The courts with respect to eleven civil districts created vide notification dated 17.10.2012 issued by the Govt. of NCT of Delhi and the Courts of Sessions and the courts of Metropolitan Magistrates for the cases of police stations under the jurisdiction of 11 sessions divisions and metropolitan areas created vide notifications dated 11.09.2012 and 17.10.2012, respectively, issued by the Govt. of NCT of Delhi, will function from the places/court complexes as under:-
