	Rs.1200/-	Senior Advocates
RFID Tag Security Deposit	Rs.600/-	One time payment refundable on surrender of the RFID Tag in working condition
General Public (including Advocates if parking more than one vehicle)	Rs10/-	For one hour, Subject to a maximum of Rs.50/- for 12 hrs. Per vehicle
Night Charges 9 AM to 11AM	Rs.100/-	Per night which shall be payable for all irrespective of possessing RFID Tags
