- 4. Regular/final hearing matters would be listed chronologically so that old matters can be given priority in disposal.
- 5. Specially directed matters may be assigned by the Chief Justice to any of the above Benches or any of the Hon'ble Judges sitting singly or to specially constituted Benches.
