3. Specially directed matters may be assigned by Hon'ble the Acting Chief Justice to any of the above Benches or any of the Hon'ble Judges sitting singly or in specially constituted Benches.
4. Regular/final hearing matters would be listed chronologically so that old matters can be given priority in disposal.
5. Hon'ble Judge In-charge, Original Side will equally distribute arbitration matters to the two arbitration Courts and other matters to the remaining Courts.
6. Bail matters, Criminal Appeals, Criminal Writs and Criminal Misc. Main Cases, pending before the board of Hon'ble Mr. Justice V.K. Shali shall stand transferred to the board of Hon'ble Mr. Justice Sudershan Kumar Misra.
7. Fresh Bail Applications shall be equally distributed amongst the roster benches of Hon'ble Mr. Justice Sudershan Kumar Misra, Hon'ble Ms. Justice Mukta Gupta and Hon'ble Mr. Justice M.L. Mehta on random basis.
8. Fresh Criminal Appeals (SB) and Criminal Misc. Main Cases shall be equally distributed amongst the roster benches of Hon'ble Mr. Justice Sudershan Kumar Misra, Hon'ble Mr. Justice Suresh Kait, Hon'ble Ms. Justice Mukta Gupta and Hon'ble Mr. Justice M.L. Mehta on random basis.
9. Fresh Criminal Revision Petitions shall be equally distributed amongst the roster benches of Hon'ble Mr. Justice Suresh Kait, Hon'ble Ms. Justice Mukta Gupta and Hon'ble Mr. Justice M.L. Mehta on random basis.
