- 4. Allocation of cases amongst the Judges in the 'Commercial Division' shall be done by the Senior Most Judge of 'Commercial Division'.

- 5. Allocation of Appeals amongst the Division Benches in the 'Commercial Appellate Division' shall be done by the Chief Justice.
- 6. Fresh Civil Writ Petitions (Misc.) shall be equally distributed between Hon'ble Mr. Justice Rajiv Sahai Endlaw and Hon'ble Mr. Justice V. Kameswar Rao.
