- 6.Regular/final hearing matters would be listed chronologically so that old matters can be given priority in disposal.

- 8.Hon'ble Judge-in-charge (Single Benches-Criminal Jurisdiction) will mark the matters which cannot be listed before roster benches or are directed to be listed before other benches.
