- 1. All the fresh PILs shall be listed before the Bench presided over by the Acting Chief Justice.
- 2. Mentioning of urgent matters will be before the Acting Chief Justice in Court No. 1.
- 3. Matters other than part-heard, presently pending before various Benches shall stand transferred to the respective Benches as per the above roster.
- 4. Regular/final hearing matters would be listed chronologically so that old matters can be given priority in disposal.
- 5. Specially directed matters may be assigned by the Acting Chief Justice to any of the above Benches or any of the Hon'ble Judges sitting singly or to specially constituted Benches.
- 6. 'Commercial Division' consists of six benches of a Single Judge each. Hon'ble Mr. Justice Manmohan, Hon'ble Mr. Justice Rajiv Sahai Endlaw; Hon'ble Ms. Justice Indermeet Kaur; Hon'ble Mr. Justice Jayant Nath; Hon'ble Mr. Justice Vibhu Bakhru; and Hon'ble Mr. Justice Yogesh Khanna have been nominated to be the Judges of the 'Commercial Division'.
