### **General Notes:**

- 1. All fresh PILs shall be listed before the Bench presided over by the Chief Justice.
- 2. PIL matters upto the year, 2018 will be taken up by DB-I from 2:15 PM onwards.
- 3. Mentioning of urgent matters will be before DB-I.
- 4. Matters other than part-heard, presently pending before various Benches, shall stand transferred to the respective Benches as per the above roster.
- 5. In terms of order dated 25.5.2021 passed by DB-I in LPA No.37/2021 and LPA No.43/2021, unless and until in the order of the Court it is mentioned that the matter be treated as "part heard", no matter shall be presumed to be "part heard" and shall be listed before the Roster Bench.
- 6. Regular/final hearing matters would be listed chronologically so that old matters can be given priority in disposal.
- 7. Specially directed matters may be assigned by the Chief Justice to any of the above Benches or any of the Hon'ble Judges sitting singly or to specially constituted Benches.
- 8. Fresh Writ Petitions challenging constitutional validity of any Act, Statutory Rule, Regulation or Notification other than tax (including Municipal tax) and Service matters shall be marked by the Chief Justice.
- 9. 'Commercial Appellate Division' has been constituted with five Division Benches, namely, DB-I, DB-II, DB-III, DB-IV and DB-V. Hon'ble Judges who are members of said five Division Benches, as per the present roster, have been nominated to be the Judges of the Commercial Appellate Division. The matters of the Commercial Appellate Division involving commercial disputes of over Rs.100 Crores shall be listed before DB-I.
- 10. Matters to be heard by the Commercial Appellate Division shall be assigned by the Chief Justice amongst the five Commercial Appellate Divisions.
- 11. 'Commercial Division' consists of six benches of a Single Judge each. Hon'ble Mr. Justice Suresh Kumar Kait, Hon'ble Mr. Justice Jayant Nath, Hon'ble Mr. Justice Vibhu Bakhru, Hon'ble Mr. Justice C. Hari Shankar, Hon'ble Mr. Justice Sanjeev Narula and Hon'ble Ms. Justice Asha Menon have been nominated to be the Judges of the 'Commercial Division'. The matters of the Commercial Division involving commercial disputes of over Rs.100 Crores shall be listed before Judge-In-Charge (Original Side).

- 12. Hon'ble Mr. Justice Suresh Kumar Kait, Hon'ble Mr. Justice Jayant Nath, Hon'ble Mr. Justice C. Hari Shankar, Hon'ble Mr. Justice Sanjeev Narula and Hon'ble Ms. Justice Asha Menon have also been nominated to function as 'IP Division'.
- 13. All fresh arbitration matters on the Original Side involving commercial dispute of above Rs.100 crores shall be listed before Judge-In-Charge (Original Side).
- 14. All fresh Execution Petitions including the petitions arising out of the Arbitration & Conciliation Act shall be listed before Judge-In-charge (Original Side).
- 15. In the event of change in the Judges nominated by the Chief Justice constituting the 'Commercial Division' and 'Commercial Appellate Division', part-heard matters shall stand transferred to the respective courts which will have the power of 'Commercial Division' and 'Commercial Appellate Division', limited to that case only.
- 16. Hon'ble Judge-in-Charge, Original Side will distribute fresh Arbitration Matters including Commercials Matters under the Arbitration Act, 1940 and the Arbitration and Conciliation Act, 1996 between 'A', 'C', 'D' & 'G' Courts.
- 17. Hon'ble Judge-in-Charge, Original Side will mark matters other than Arbitration Matters including Commercial Matters to 'B', 'C', 'D', & 'F' Courts.
- 18. All the Hon'ble Judges on the Original Side of this Court are empowered to deal with suits/petitions arising under the Arbitration and Conciliation Act,1996 falling under Section 20-B of the Specific Relief Act,1963.
- 19. Fresh Bail Applications shall be equally distributed amongst all Single Bench Judges sitting on the Criminal Roster.
- 20. Fresh Criminal Leave Petitions shall be equally distributed between Hon'ble Ms. Justice Mukta Gupta, Hon'ble Ms. Justice Anu Malhotra, and Hon'ble Mr. Justice Yogesh Khanna.
- 21. Fresh Criminal Appeals shall be equally distributed amongst Hon'ble Ms. Justice Mukta Gupta, Hon'ble Ms. Justice Anu Malhotra, Hon'ble Mr. Justice Yogesh Khanna, Hon'ble Mr. Justice Chandra Dhari Singh, Hon'ble Mr. Justice Subramonium Prasad, Hon'ble Mr. Justice Manoj Kumar Ohri and Hon'ble Mr. Justice Rajnish Bhatnagar.
- 22. Fresh Criminal Writ Petitions shall be equally distributed amongst Hon'ble Ms. Justice Mukta Gupta, Hon'ble Mr. Justice Yogesh Khanna and Hon'ble Mr. Justice Subramonium Prasad.
- 23. Fresh Criminal Revision Petitions shall be equally distributed amongst Hon'ble Ms. Justice Mukta Gupta, Hon'ble Ms. Justice Anu Malhotra, Hon'ble Mr. Justice Yogesh Khanna, Hon'ble Mr. Justice Chandra Dhari Singh, Hon'ble Mr. Justice Subramonium Prasad, Hon'ble Mr. Justice Manoj Kumar Ohri and Hon'ble Mr. Justice Rajnish Bhatnagar.
- 24. Fresh Criminal Misc. Main Cases shall be equally distributed amongst Hon'ble Ms. Justice Mukta Gupta, Hon'ble Ms. Justice Anu Malhotra, Hon'ble Mr. Justice Yogesh Khanna, Hon'ble Mr. Justice Chandra Dhari Singh, Hon'ble Mr. Justice Subramonium Prasad, Hon'ble Mr. Justice Manoj Kumar Ohri and Hon'ble Mr. Justice Rajnish Bhatnagar.
- 25. Fresh cases relating to sexual harassment shall be distributed category wise according to roster.
- 26. The cases of the convicts/appellants in jail, whose sentence is about to be completed or have completed the substantial period of the maximum sentence of the offence charged against them, shall be taken up on priority basis and every endeavor should be made to dispose of the same expeditiously.
