- 2. Mentioning of urgent matters will be before the Acting Chief Justice in Court No. 1.
- 3. Matters other than part-heard, presently pending before various Benches shall stand transferred to the respective Benches as per the above roster.
- 4. Regular/final hearing matters would be listed chronologically so that old matters can be given priority in disposal.
- 5. Specially directed matters may be assigned by the Acting Chief Justice to any of the above Benches or any of the Hon'ble Judges sitting singly or to specially constituted Benches.
- 6. Pending Writ Petitions challenging the constitutional validity of any Act, Statutory Rule, Regulation or Notification other than tax (including Municipal tax) and Service matters on the Board of DB-I shall be distributed/marked by the Acting Chief Justice amongst the concerned Benches.
- 7. Fresh Writ Petitions challenging the constitutional validity of any Act, Statutory Rule, Regulation or Notification other than tax (including Municipal tax) and Service matters shall be marked by Acting Chief Justice.
