- 1. All fresh PILs shall be listed before the Bench presided over by the Chief Justice.
- 2. PIL matters upto the year, 2018 will be taken up by DB-I from 2:15 PM onwards.
- 3. Letters Patent Appeals of the year, 2018 will be taken up by DB-I from 2:15 PM.
- 4. Mentioning of urgent matters will be before DB-I.
- 5. Matters other than part-heard, presently pending before various Benches, shall stand transferred to the respective Benches as per the above roster.
- 6. Regular/final hearing matters would be listed chronologically so that old matters can be given priority in disposal.
- 7. Specially directed matters may be assigned by the Chief Justice to any of the above Benches or any of the Hon'ble Judges sitting singly or to specially constituted Benches.
- 8. Fresh Writ Petitions challenging constitutional validity of any Act, Statutory Rule, Regulation or Notification other than tax (including Municipal tax) and Service matters shall be marked by the Chief Justice.
- 9. Fresh Criminal Appeals shall, as far as practicable, be equally distributed between DB-III and DB-VII.

Kameswar Rao, Hon'ble Ms. Justice Rekha Palli, Hon'ble Ms. Justice Jyoti Singh and Hon'ble Mr. Justice Prateek Jalan have been nominated to be the Judges of the 'Commercial Division'.

- 14. In the event of change in the Judges nominated by the Chief Justice constituting the 'Commercial Division' and 'Commercial Appellate Division', part-heard matters shall stand transferred to the respective courts which will have the power of 'Commercial Division' and 'Commercial Appellate Division', limited to that case only.
- 15. Hon'ble Judge-in-Charge, Original Side will distribute fresh Arbitration Matters including Commercials Matters under the Arbitration Act, 1940 and the Arbitration and Conciliation Act, 1996 between 'A', 'B' & 'G' Courts.
- 16. Hon'ble Judge-in-Charge, Original Side will mark matters other than Arbitration Matters including Commercial Matters to 'A', 'C', 'D', & 'F' Courts.
- 17. All the Hon'ble Judges on the Original Side of this Court are empowered to deal with suits/petitions arising under the Arbitration and Conciliation Act,1996 falling under Section 20-B of the Specific Relief Act,1963.
- 18. Fresh Bail Applications shall be equally distributed amongst all Single Bench Judges sitting on the Criminal Roster.
- 19. Fresh Criminal Leave Petitions shall be equally distributed between Hon'ble Mr. Justice Vibhu Bakhru and Hon'ble Mr. Justice Brijesh Sethi.
- 20. Fresh Criminal Appeals shall be equally distributed amongst Hon'ble Mr. Justice Suresh Kumar Kait, Hon'ble Mr. Justice Vibhu Bakhru, Hon'ble Ms. Justice Anu Malhotra, Hon'ble Mr. Justice Yogesh Khanna, Hon'ble Mr. Justice Manoj Kumar Ohri, and Hon'ble Mr. Justice Brijesh Sethi.
- 21. Fresh Criminal Writ Petitions shall be equally distributed amongst Hon'ble Mr. Justice Vibhu Bakhru, Hon'ble Mr. Justice Yogesh Khanna and Hon'ble Mr. Justice Brijesh Sethi.
- 22. Fresh Criminal Revision Petitions shall be equally distributed amongst Hon'ble Mr. Justice Suresh Kumar Kait, Hon'ble Mr. Justice Vibhu Bakhru, Hon'ble Mr. Justice Yogesh Khanna, Hon'ble Mr. Justice Manoj Kumar Ohri and Hon'ble Mr. Justice Brijesh Sethi.
- 23. Fresh Criminal Misc. Main Cases shall be equally distributed amongst Hon'ble Mr. Justice Suresh Kumar Kait, Hon'ble Ms. Justice Anu Malhotra, Hon'ble Mr. Justice Yogesh Khanna and Hon'ble Mr. Justice Manoj Kumar Ohri.
- 24. Fresh cases relating to sexual harassment shall be distributed category wise according to roster.
- 25. The cases of the convicts/appellants in jail, whose sentence is about to be completed or have completed the substantial period of the maximum sentence of the offence charged against them, shall be taken up on priority basis and every endeavour should be made to dispose of the same expeditiously.
